Heard County Water Authority Board Meeting Minutes Feb 20, 2023

The Heard County Water Authority Board met in regular session on February 20, 2023, at 5:00 p.m. The following members were present: James Ray Gosdin, Loy Howard, Alvin Ginn, Tommie McKeever, and Shane Cammon.

Chairman Gosdin called the meeting to order. Joe Jones gave the invocation and led the Pledge of Allegiance.

Recognition of Guests: Barry Smith, Auditor & Phyllis Woodson

Approve Agenda: On motion and second (Cammon, Ginn) a unanimous vote was made to approve the agenda.

Approve Minutes: On motion and second (Cammon, Ginn) a unanimous vote was made to approve the minutes for January 2023.

New Business:

Board Vote for Officers in 2023: Due to Alvin Ginn resigning from the board, he suggested that this vote be tabled until next month. On motion and second (Ginn, Cammon) a unanimous vote was made to table the vote until next month.

FY 22 Audit Review: Barry Smith, Auditor presented the FY 22 Audit to the board. He went over the figures and findings on the report. He stated that the Audit was given an unmodified opinion which is the highest "score" for an Audit. He also told the board that the two other categories from the Audit, the Yellowbook portion and the Single Audit were also given an unmodified opinion. Alvin Ginn asked him how we looked on the financial aspect of the Audit and what "grade" he would give HCWA. Smith advised that HCWA was very stable and if there was a situation where no income came in, HCWA could keep operating for at least 6 months, while most Government Agencies can only operate around 3 to 3 ½ months with no income. Barry stated that his grade for HCWA on that matter would be an A+. Howard recommended a response to the Letter from the Auditor which listed 3 topics HCWA needs to review and consider changes. On motion and second (Howard, Ginn) a unanimous vote was made to respond to the Auditor's letter with a written response.

Board Member's Education: Director Cook and Attorney Michael Hill presented a document that stated basic guidelines for the HCWA board members. In light of having a new Board Member appointed, Director Cook and Attorney Hill felt that it would be great to have a document for current HCWA Board Members and new HCWA Board Members to have as a guide on the duties and ethics of being a Board Member.

Old Business:

DOT Project on HWY 34 E Update: Director Cook gave on update on the DOT project on HWY 34 E. She has composed a letter to request Utility Aid for the project. Cook presented a preliminary cost estimate on the project. \$197,190.00 plus the estimated cost of Engineering in the amount of \$18,500.00. Director Cook never received any notice as to this project therefore the window of time to be granted Utility Aid has passed. She is sending in the letter and the other requirements needed in hopes of being able to receive financial assistance. Vice-Chairman, Loy Howard will contact GDOT Board Member Dennis McIntyre to discuss this situation with him and hopefully come to a resolution.
